Customer is responsible for obtaining releases, permits, agreements, etc... from any and all copyright holder(s) pictures, music, logos, etc... and all individuals (e.g. talent, background actors, etc...) included in this production. Customer warrants and represents that they have, or shall obtain, sufficient personal injury and property damage liability insurance for the event and activities NP is being hired for and the place of the occasion. A deposit is required and nonrefundable unless NP initiates a cancellation. Balance due is expected at the time of the event. Start and end times of any part(s) of the production and final cost of the production may change at any time at the discretion of NP, independent of this or any contract. Customer understands that under no circumstance is a refund an option after the event has been videographed, unless NP decides otherwise. Customer is responsible for maintaining a copy of the production. NP is not responsible for archiving or backing up the production. Customer shall provide each member of NP as needed with free water/beverages, tickets to the occasion, free meals, and lodging that is safe, clean, and sufficient for NP to complete production. In case of cancellation by customer for any reason customer is responsible for reimbursing NP, outside of deposit, for any and all cost incurred. The final production belongs to the customer and customer authorizes NP to fix the sounds or images or sounds and images of the event in a copy or phonorecord, or reproduce copies or phonorecords of event. Customer gives NP exclusive permission to transmit or otherwise communicate to the public the sounds or images, or sounds and images of the event.
